

Daily Reported Cases





2. International Overview

As of **05:00** EDT, **28 Sep**, the number of positive COVID-19 cases globally is **33,119,791** including **997,966** deaths with **22,930,309** individuals having recovered. Three countries (US, India, and Brazil) make up 54% of international cases. The number of cases and deaths for these countries is: US (**7,115,338/204,758**), India (**6,074,702/95,542**), and Brazil (**4,732,309/141,741**).

3. Key Updates

Border Issues

The Canada-US border will remain closed to non-essential travel until 21 Oct, as • both countries continue to work towards stopping the spread of COVID-19.

- The deployment of CRC to QC in Long Term Care Facilities (LTCF) began • 03 Jul and as of 24 Sep, the CRC has a total of 466 personnel (34 CRC teams) currently deployed at 17 LTCF.

4. Media Summary

On 25 Sep, Prime Minister Justin Trudeau will join Canada's top public health officers for their daily update on the worsening COVID-19 health crisis. The PM was expected to have an announcement about the government's ongoing efforts to protect Canadians and combat the potentially deadly novel coronavirus that causes COVID-19. He is also expected to start joining Chief public health officer Dr. Theresa Tam and her deputy, Howard Njoo, more regularly at their daily briefings.

- On 25 Sep, Prime Minister Justin Trudeau announced an agreement with • AstraZeneca to procure up to 20 million doses of its COVID 19 vaccine candidate. This agreement adds to those already reached with Sanofi and GlaxoSmithKline, Johnson & Johnson, Novavax, Pfizer, and Moderna, which were made following the recommendations of the COVID-19 Vaccine Task Force. - The Prime Minister also announced Canada's participation in the COVID-19 Vaccine Global Access (COVAX) Facility, a global procurement mechanism that will help deliver fair, equitable, and timely access to COVID-19 vaccines. The Government of Canada is committing approximately \$220 million to the Facility to procure up to 15 million vaccine doses for Canadians. An additional \$220 million will be channeled through the COVAX Advance Market Commitment to purchase doses for low- and middle-income

countries, because we cannot beat this virus in Canada unless we end it everywhere. By joining this initiative, Canada is helping to develop and deploy safe, effective, and accessible COVID-19 vaccines.

- ON is investing \$741 million to help clear the backlog of surgeries and build more capacity in the health care system to effectively manage surges and outbreaks in COVID-19 cases. This is part of the province's COVID-19 fall preparedness plan, Keeping Ontarians Safe: Preparing for Future Waves of COVID-19. - On 25 Sep, some Ontario pharmacies will begin offering COVID-19 tests as the province tries to ease the burden on busy assessment centres. Up to 60 pharmacies are offering the appointment-only tests to certain asymptomatic individuals, such as those with loved ones in long-term care homes, close contacts of a case or high-risk workers. Meanwhile, the government announced yesterday that the province's assessment centres will now focus on testing those with symptoms, exposure to a case and people involved in outbreak investigations.

- There were 637 new cases and four deaths reported on 25 Sep (36 cases in the Outaouais region).
- There were 698 new cases and seven deaths reported on 26 Sep (21 cases in the Outaouais region).
- There were **896** new cases and **four** deaths reported on **27 Sep (14 cases in the Outaouais region)**.
- A slow but steady rise of COVID-19 cases in Quebec's private seniors residences in recent weeks is causing concern among experts and authorities, who want to avoid the disaster that befell long-term care homes during the first wave of the novel coronavirus. As of 23 Sep, there were 39 private residences in Quebec with 180 COVID-19 cases between them listed on the government's website. Four among them were described as "critical" because more than 25 per cent of their residents were infected. In comparison, only 20 long-term care homes were listed as having cases. One facility was listed as critical.

6. Emergency Support Functions and Critical Infrastructure

- Priority access to scarce resources, such as:
 - PPE and COVID-19 testing kits.
- Heightened cybersecurity surveillance and cyber incident information sharing to help ensure cyber-safe operations; and
- Support for return to workplace planning, in particular robust contact tracing.

ESF #1 Transportation

• On 24 Sep, the Edmonton International Airport announced in a press release it will exclusively trial a new COVID-19 saliva test developed by GLC Medical Inc. The test is conducted with a handheld unit that takes a saliva sample from a person and is expected to tell if someone has COVID-19 in under 1-minute. Details about the testing and the process will be shared in the coming weeks. A start date has not been determined, but once it begins, the clinical trial will last several weeks over this fall. ESF #7 Employment and Social Development Canada

 On 24 Sep, the Deputy Prime Minister and Finance Minister, Chrystia Freeland, and the Minister of Employment, Workforce Development and Disability Inclusion, Carla Qualtrough, announced the introduction of Bill C-2, to create three new temporary Recovery Benefits to support Canadians who are unable to work for reasons related to COVID-19. These new Benefits are being proposed as part of the Government of Canada's plan to support Canadians as we work to build back a stronger, more resilient economy. Since the introduction of the Canada Emergency Response Benefit (CERB) in the early days of the pandemic, at a time when we asked Canadians to stay home, close to 9 million Canadians have received the Benefit to help to pay their bills and support their families.


To help build a stronger workforce, the Government of Canada will also invest an additional \$1.5 billion in the Workforce Development Agreements with provinces and territories to offer Canadians the skills training and employment supports they need. This support will respond to the increased number of Canadians looking to re-enter the workforce, and targets workers and employers in sectors hardest-hit by COVID-19, as well as groups particularly disadvantaged as a result of the pandemic. This is in addition to the \$3.4 billion already being provided to provinces and territories under the Labour Market Development Agreements and Workforce Development Agreements in 2020-2021.

ESF #13 Border Services

- As of 27 Sep, 4,042,807 travellers were processed on the desktop application in all modes. Of these, 3,091,328 (76.5%) were exempt from mandatory selfisolation. The remaining 951,479 (23.5%) were subject to the mandatory selfisolation or quarantine order.

Indigenous Services Canada (ISC)

- On First Nations communities in the provinces, as of 25 Sep there were:
 - o 647 (+8) confirmed positive cases of COVID-19;
 - o 52 hospitalizations;
 - o 11 deaths;
 - 518 (+6) recovered cases;
- As of 16 Sep, there are 191 State of Local Emergency (SOLE) declarations by First Nation communities in response to the COVID-19 crisis, which represents 30% of all First Nations in the selected regions.
