Hi lain,

Further to your request for an assessment of the COVID procurement process, I'm attaching a report my internal audit team has prepared. This consulting project focused on contracting that was done early in the response (mid-February to April) and examined highest-risk files at that time. You will see that the comprehensive review of these files revealed a number of issues – not unexpected, given the urgency of the actions. That said, my team worked closely with Carlo's team as findings were coming in so that issues could be resolved. As well, Carlo's team used these findings as well as other work they were doing to strengthen processes to help avoid these issues moving forward.

Carlo's team has prepared a management action plan (attached) to address issues raised in this report which will provide clarity on what is being done to address these findings. He has also provided an overall contracting document that was developed by OCFO and which provides a more comprehensive story on COVID contracting.

My team is also now working on a phase two of this project, to look at procurement files post-April.

At my last job sometimes we would borrow brain power from A and E to help us with a certain kind of analytical work.

Do we ever do that here?

What I am thinking I would like from Debbie is a note on our mandate and so appropriate range of procurements, our internal procurement authorities delegation, and the analytical and approval processes that we have been following when asking PSPC to undertake procurements on our behalf of

- vaccines
- therapeutics
- PPE
- testing?

After Debbie's team sets out the authorities and the process, we could have Shelley's team do a light touch review of a sample of different sorts of transactions and to make sure those steps and processes have been followed and ensure that the paper is on hand to demonstrate.

This is not an audit and my hope is we can do this relatively lightly in order to have assurance as a management team that we have a clear authorities, a clear process, and then also that we have assurance on quality control that we have been doing things this way.

If we surface issues the idea would be that as a management team we then can address to tidy up or correct any issues.
