## Hey Zoe,

Don't think this is ready for an announcement yet. At the first PPE working group meeting the Minister brought forward concerns coming from Ag on the need for ppe but didn't have firm data on exactly what the ask is, what amount of stockpile companies currently have available and what the different needs are between larger and smaller operators.
