>> I just spoke with our DM of Health and he articulated that we are in the "second wave" of PPE equipment that is being procured federally.
>>
>> Apparently on a call last night, the health deputies all discussed instead of leaving some provinces out of the first wave of orders (which the PPE is now in the country) to split it up amongst all PT's so that everyone gets some from the first wave of equipment instead of some PT's having to wait for the second order. He mentioned that "most" PT's were in favour - but not all.
>>
>> It is critical that we get a 2-3 week of PPE supplies ASAP. With more testing, more patients presenting with symptoms, and more positive cases - we will only be able to last another 5-7 days without some supplies being received.
>>
>> I know demands are high, but some supplies to get us through the next two weeks while we wait for the second wave of equipment is very much needed here on PEI.
