Thank you! Just a few things, otherwise good for issues:

TBS Guidebook doc:

- The preamble calls Dr. Tam the Chief Medical Officer of Canada, should be Chief Public Health Officer.
- Doc says DMs are being called upon to determine which employees ought to be asked to return to their usual workplaces to support critical services, economic recovery or government priorities. Wondering if it can say **eventual** economic recovery?

17 pg COVID-19 Recovery tip sheet doc (PDF):

- The title at the top of one of the tip sheets (it is white & in large font) is "COVID-19 Recovery." If it is not too late, could the title be "safe re-opening" or "safe restart"?

Q&A doc:

- In an "if pressed" it says that there is no plan to post employee leave data publicly. TBS dept. committed to sharing this information with OGGO committee very soon, which will go up on the committee webpage afterwards, so would perhaps modify to say no plan to post the data on the TBS website.
- If possible, it should say somewhere in the comms lines that **should** there be limited availability & an influx of PPE and other medical supplies requests for things like surgical masks, gloves and hand sanitizer from departments & the healthcare sector via P/Ts, PSPC will continue to prioritize requests for the healthcare sector.
