PROPOSED RESPONSE (for your approval):

The Government is taking an aggressive, proactive procurement approach to fulfill immediate and future requirements. This includes buying in bulk from reputable

distributors, to secure key items like masks and ventilators, which are in high global demand.

Given the highly fluid nature of this situation, we are not providing details about orders with specific suppliers.

To date, the Government of Canada has ordered more than 157 million surgical masks (including some from Medicom), and more than 1,500 ventilators (including a portion from Thornhill Medical).

In addition, we have placed orders for enough test kits to test millions of Canadians, some of which will come from Spartan Bioscience.

Previously response on procurement provided March 30, 2020.

Our number one priority, right now, is getting the supplies needed, as quickly as possible, to protect public health. As the COVID-19 situation is very fluid and evolving rapidly every day, so are the requirements and orders.

We are exploring options for how we can report information related to these procurements—balancing our collective desire for transparency with the realities we are all facing at this time.
