Attached and below is the latest PPE update for the web.
 Other than a significant boost in gowns (+15.6-million), there isn't huge movement anywhere. Somewhat concerning is the fact that no gloves have been delivered in the last two weeks. I asked to make sure that wasn't a mistake and am told it is not and that the DM has raised concerns about this as well. I'm told there should be approximately 12-million pairs of gloves arriving over the course of the next few days.

There is no reduction in orders – and two slight increases to face shields and face coverings as listed below. Here is a table with a summary of the changes and below that is the web-chart.
