Hi Adam/Shannon/Chelsea,

I appreciate how busy you all are, but if you allow me, I just wanted to touch base because we have not heard from anyone to date regarding the ventilators we secured for Canada.

It has been a few weeks that have passed and we are concerned that the ventilators we went to great efforts to secure for Canada's battle against Covid-19 might be sold to another country because we waited too long. These ventilators are already built, packaged and boxed. There are ready for shipment.

The VG 70 ventilators are US FDA approved, on their list of approved Covid-19 equipment, on the Chinese Government's list of approved ventilators for export and available in warehouse in Beijing ready for shipment. Two weeks ago we had 700 units in the warehouse.

The units are 39K USD per unit. These prices reflect the current market for already built machines, boxed and shipped, ready to go. If you ordered machines in the past month, they will not be delivered until November and you still have to pay the full price (39K USD) up front. The machines we have are ready to go. As I mentioned to you previously, our US partner has already sold these machines to the State of Maryland.

I wanted to follow up with you regarding the ventilators and our submission to the web portal you provided.

The reference number is 51793

The model ventilator has been approved by the US FDA and can be found on their official list of approved equipment. I provided you with a link to their list, below.

As you know, it is a Wild West out there for equipment; lots of promises, but no delivery. But we have them. I sent you photos of the actual ventilators as they sit on pallets. They are real. They just need documents and payment and they can be delivered in less than a week if we can secure air freight.

I just don't know how long we will be able to hold on them for.

If you can advise your intentions it would be greatly appreciated.

I wanted to follow up with you on your question of  
whether Medeeco Ltd. could provide ventilators.

We can provide ventilators.

Our US partner, Critical Care Solutions, are  
bringing them in from their supplier in China with  
all the necessary electrical changes to operate in  
North America.

To give you an idea at which the speed they are  
moving in the US. Critical Care Solutions began  
discussions with the State of Maryland on Friday  
April 3, received a letter of intent from State on  
Saturday April 4 and payment for 50% of the cost  
on the morning of Monday April 6, who then sent  
the money to their supplier a few hours later.  
Delivery is expected this week.

I have attached two files for you. They are  
brochures of the two models of ventilators we can  
provide.
