As a Canadian business owner, we should also share with you the first phase of Canada's COVID-19 Economic Response Plan, we are providing immediate help to those Canadians and businesses that are most in need. We understand that Canadians are worried, and that many businesses need support as we work through this evolving global challenge of COVID-19. We hear your request and we also want to let you know what we are putting in place. We acknowledge there will be more to do. The Prime Minister announced a number of measures to support workers and businesses including:

- A 10% wage subsidy for three months, so that employers can keep their employees. We hear you that this is not enough.
- An Emergency Support Benefit and an Emergency Care Benefit for people not typically covered by Employment Insurance (EI).
- We have waived the one week waiting period for EI sickness benefits.

To help provide some stability for businesses through this time of uncertainty, the Office of the Superintendent of Financial Institutions<<https://www.osfi-bsif.gc.ca/Eng/Pages/default.aspx>> (OSFI) is lowering the Domestic Stability Buffer requirement, releasing more than \$300 billion of additional lending capacity for Canadian financial institutions.

Our southern Ontario economic development agency, FedDev is also a source of information and can connect you:

- a) Organizations that are currently receiving FedDev Ontario funding already have a FedDev Ontario economic development officer with whom they work regularly. If these organizations are looking for additional funding or flexibility on loan repayment, they should contact their existing officer (varies company by company) who will help them navigate options for enhanced support.
- b) Organizations that are not currently receiving FedDev funding, but are looking for support should contact FedDev's business support line at 1-866-593-5505. All organizations who call this line are assigned an officer who will help them navigate options for support.

We are recalling the House to introduce legislation to make the required changes to advance these measures. We would like to assure you that all parties and all levels of government are working well together. We understand there is more to do, and we are working diligently to provide the supports necessary.

We hope this information is of assistance. Thank you again for taking the time to write to our office.
