Collaborative and bulk purchase orders are **already underway** with a number of jurisdictions. This will be an ongoing process as the demand for and supply of products evolves. Federal, provincial and territorial governments continue to work together to identify priority items, collaborate on procurement, and assess potential shortfalls.
