Here are the latest vaccine lines as approved by Doug. Here is his comment: "This is very good. In the responsive lines, we cannot say that he will "lead" the task force as this implies he will be managing resources and implies an employee-employer relationship. As in the rest of the note, he should be framed as providing senior-level advice and expertise." To address Doug's concern, I have revised the fourth bullet. I have also added a Health Canada Q&A based on the answer from Industry Sector.

Margot and Olu haven't approved these yet. Margot tells me there was something going on about a member of the vaccine taskforce, so Olu wants us to ensure that Miriam and Taylor are looped in on the Guy Bujold lines, as we may need to add something additional about what was happening. Margot says she will loop in Taylor and Miriam. You might want to follow-up with them. If anything has to be added to the lines about this issue we will need to add it before the lines go back to Margot and Olu for approval.
