Hi Nathaniel & Andy,

That's great, except that the nurses and doctors are running out of PPE etc... right now. It is my understanding that we are mired in some kind of bureaucratic paralysis.

I have access to a machine from China that costs \$1 million RMB or approx \$600, 000 Canadian give or take, I also have access to the masks and all sorts of materials.

This machine is fully automated and prints 1 million masks per day at push of a button.

The problem I face with my friend who has travelling extensively to China and has a great network is the following:

1. How would we get this machine actually through customers/border control at this point in time (Some kind of Urgent designation would be nice to clear customs/border)
2. Also my Canadian friend only has a work visa currently so he would not be allowed to enter China until they either relax current rules (unlikely) or with Canadian gov't help.
(this is more an option for down the road, but worth stating as a contact Canadian on the ground in China would be extremely valuable - my friend is mainland connected not just via Hong Kong, or importer/resellers.

Point 1. is most urgent to me as I have many family and friends from Beaches/EY area that work in the health care field.

You guys both know that this is about to get very brutal as our front-line workers are getting exhausted and being forced to ration masks.

If we can get this machine into Canada it would provide us with our own mask supply for the Toronto region!

I don't really care about the money part right now as I believe it is very doable, but if the machine or PPE can't actually get in the country what's the point.

I'm reaching out to you first because you went to my high school and you probably know my sister and have worked with one of my close friends.

If you are not interested let me know immediately so I can reach out to provincial reps, city reps, and op parties.
