Grand Chief Norton has offered facilities to support the production of hand sanitizer in Kahnawake. Please see below the text he sent me earlier today and an email he forwarded with additional information and photos.

Morning Jesse. I have been in discussions with a businessman in Kahnawake. Who is the sole owner of a state of the art distillery (Abdido) I approached him after watching a story on CBC regarding a distillery in Toronto that retooled it's facility to produce hand sanitizer. The businessman is willing to also retool to produce HS. It's a native owned company. We have been in touch with an expert in the field and have exchanged information that

could produce WHO/International standard quality products. From the research that has been done there seems to be an incredible shortage for HS. We do not have time to do an extensive pheasability study of national needs. This could be solely for the FN sector or regular Canadian usage. Please this information on to the Minister and ask him to speak to his colleagues. I will forward you pictures of the facilities if you wish and open to inspection if required.

I will work with Nicholas (copied) to connect with either Minister Bains' (and/or Minister Anand's) Office to feed the proposal into the system. As you are aware, the Government of Canada has recently announced measures to mobilize industry in the fight against COVID-19 (Prime Minister announces Canada's Plan to Mobilize Industry to fight COVID-19).

Also, as noted in the briefing note I provide prior to cabinet committee on Thursday, Kahnawake has confirmed a case of COVID-19 (link). It was the first known case in an Indigenous community in Canada.

We plan to set you up with a series of calls to Indigenous leaders for the upcoming week. We have included Grand Chief Norton in the list of calls.
