As discussed earlier over the phone, I have been in touch with a PPE supplier in China and was able to secure a spot for a shipment of N95 masks, face shield and surgical masks as well as vinyl gloves. These products are all certified for use by the UAE government and have been sold there for a long time, as the supplier is one of the main Government suppliers in the UAE.

I can provide more details on certification, requirements, order quantity etc. once I am able to confirm if the Government (health Canada) is interested.

I would love to speak to someone more about this, as the online page set up by the Government is not particularly useful and I would love to assist with this urgent issue as the lead time is 3-4 weeks from time of purchase.
