This mask is manufactured by **Rizhao Sanqi Medical & Health Articles Co., Ltd.** The product code is **RIZSQ100Sb**, a cup-shaped N95 mask with head bands.

- NIOSH certificate for product code RIZSQ100Sb: 84A-8109
