Thank you for following up.

Here is some information on one supplier of KN masks. They are CE, FDA, and ISO Certified. They have also been tested by Nielson Laboratories and have met NIOSH standards.

These masks are being used in Wuhan by Chinese government, in Europe, and the United States hospitals on the front lines of this virus.

Frankly my only point is this. Currently hospitals have no masks. Nurses are talking and treating patients with surgical masks which offer zero protection from the virus. In fact some studies show they may even increase the chances of contamination. Other countries are moving quickly and protecting their nurses and doctors while preventing the spread of the virus. Here we are debating semantics, meanwhile people are naked in battle. For a first world country this is beyond embarrassing, its approaching negligence.
