Below is the list of products with links to their certification. If you can not view this file, please let me know so I can send you something you can read.

Pricing is in USD and is to the door for a company in the USA. If you want to move forward with this I will get you an accurate quote in CAD as the time of ordering to your dock. For me this is a community service, and as such I am donating any profit from any purchase to the hospital. In other words, you will be paying the exact landed cost to get the product to you. This is a big reason why you are seeing the document sent to me by my supplier.

As we are dealing directly with the factories in China, we will need to have a substantial enough order for them to consider. As such, if there are other hospitals in Northern Ontario that have a need please forward this to them so we can send a larger combined order to keep everyone's costs down. Assuming we move early enough, these products can be here within two to three weeks when shipped by air. As a result of the COVID 19 crisis, air shipping is at a premium which can result in an inflated cost. My partners are telling me that the factory costs are increasing every day as the demand is rising. So please give this consideration sooner than later.
