We have now received updated information on our COVID-19 virus test kit, as you will see in the attached pdf document.

In addition, there is a link to a video that shows how the device is used. We apologize for the use of the term "poil" pouch as opposed to "foil" pouch, but that was an example of a small "lost in translation" issue! The link to the video is:

Pricing for these test kits is \$18-\$20 USD, depending on volumes.

Currently we believe we can secure 100K units per week, starting almost immediately and extending until supply is no longer required.
