Hi all, left some comments in here. My main comment is that I don't think we're going to get away with giving the big order numbers without more evidence of deliveries (which pspc should confirm) or what's been going out to provinces (which is phac).

Maybe she has to bluntly acknowledge that this ordering is only step 1. Step 2 is working major logisitics to get supplies here against a difficult global backdrop. And doing that fast enough to be able to backstop the provinces urgent needs.

The tone is "we're doing a ton of work, but I know we're nowhere near done, and big challenges remain."
