CONTEXT (for your information):

The reporter mentions the PM referred this morning in his daily news conference to two federally chartered PPE flights that returned to Canada from China empty, and he cited a decision by Chinese authorities. He would like to obtain more information.

Media Relations recommends using the same statement previously approved and used by MO, today April 21, 2020, to respond to this media request.
