We have managed an agreement with one of our larger suppliers that normally require a minimum of 1 million masks for the **H19M006**. You can now order our Premium Level 1 Surgical Mask (H19M006) with a minimum order of **25,000** Units. Delivery is approx. May 15th, 2020.

For all other orders (excluding H19M007/8), Minimum Mask Order is **10,000** Surgical Masks and **5,000** KN95s.

# Additional Commentary (mostly repetitive if you have been on this list for a few days)

This month alone Oliberte Limited has now placed, shipped or delivered 7+ Million masks serving a variety and size of groups with State/Provincial Governments (in Canada and USA), Local Municipalities, Hospitals, Other Health Care Units, Charities and Essential Business Services shipping to Canada, USA, Europe, Australia and Kenya.

#### **Our Factories**

As of today, we now have **11** suppliers we are working with in China and we are continuing to bring on more. Currently, in order to be a supplier with us the factories must comply with the following requirements, by providing documentation which we are checking abroad and locally with our team in China:

- Be able to produce Civilian, Medical and Surgical masks and/or KN95/N95 that are FDA and/ CE Compliant (to be verified by our team)
- The factory must be a legal business in China
- The factory must be on the list of NMPA-approved Manufacturers of PPE and Medical Device, provided by the CCCMHPIE
- The factory's products must be on the Medical Device Registration in China
- The factory must have a legal export license in China
- The factory must be able to provide all the technical specifications on their products in English and/or Chinese

#### On-Site Team in China

- In China we have our own staff that are supporting our mask production at a variety of factories for a number of customers.
- Work includes:
  - oConfirmation and Follow up of Orders
  - Regular communication with Head Office in Canada on status, potential issues and general updates.
  - oFor larger orders we place 1-2 of our staff in the assigned factory during the production period to ensure quality, product and packaging is as expected; in addition to ensure production is on schedule once started.

# **Current Minimum Requirements**

- 10,000 masks for Medical or Non-Medical Surgical Mask
- 5,000 masks for KN95 (not we no longer are offering the FFP2)
- 25,000 masks for H19M006: Delivery May 15th, 2020

• Each Minimum per Location. ie if you want Oliberte to ship an order to 2 locations you need to order min. 20,000 surgical masks.

## Payment Terms

- 50% on order paid by wire, EFT or Credit Card. For Credit Card a 3% charge applies
- 25% is due once our team on the ground has confirmed that the production is done and our entire inspection is complete. During the production run we will be performing a number of quality and random inspection checks. Once order is completed and counts are verified, we will provide pictures of the inspection conducted, the stock and photos of the product. Once this is provided this payment portion is due.
- 25% once your shipment has left by Air and we confirm export customs have been cleared;
  we will also provide tracking to you.
