 - $\circ~$ The first two contribution agreements to be set up in line with the VTF's recommendations (Medicago and VBI, last I heard)
 - A Supercluster vaccine announcement (Immunovaccine Technologies, whose project is supported by NGen, NRC IRAP, and ACOA – IRAP comms is aware for the IRAP angle)

ABOUT THE PRODUCTS:

I've attached clean copies of each product. I did a parallel read between these versions and the previous versions we reviewed and sent back. The speech (SP) and news release (NR) are quite consistent and nothing regarding the VTF has changed appreciably. VTF mentions are highlighted in blue.

In the Special Backgrounder (SBK), there is a new QA on international vaccine candidates (Q4, page 11). Because the SBK is so long, I've highlighted in grey all mentions of the NRC or the VTF that have not changed since last review, and kept in blue what has changed so you don't have to read through everything again. There is also a new section in the SBK on the Therapeutics Task Force which includes some VTF mentions.
