### **Supply Hub**

Following tomorrow's procurement update at COVID Committee, we are advised by PSPC that Minister Ana is expected to issue a news release to announce the creation of the Supply Hub, an online federal web site that will act as a resource for businesses and other organizations interesting in buying and selling personal protective equipment (PPE) supplies.

Part of PSPC's multi-faceted approach to procurement in response to COVID-19, the Supply Hub will act as a "one stop shop" for buyers and sellers. It will include information on PPE product specifications, procurement opportunities, and resources with respect to importing PPE; new links and content will be added on an ongoing basis.

For those looking to purchase PPE, the Supply Hub will offer information on fair pricing of PPE, links to province and territory-specific initiatives, supplier lists, and consumer guidance on resources. The Supply Hub also includes a disclaimer indicating that the Government of Canada has not endorsed, recommended or approved the suitability of any product or service listed on external sites. By connecting buyers and sellers, providing guidance, and linking to external organizations, the federal government's Supply Hub is intended to help Canadian businesses and organizations access much-needed supplies of PPE.
