Hello – please see below for some updates from tonight’s call:

PSPC:

- One PPE plane on Friday
 - 756k gloves, 1.5m surgical masks, 100k gowns
- One PPE plane on Saturday
 - 9m surgical masks, 390k+ pairs of goggles
- Three PPE planes on Sunday
 - **One was a non-GC chartered plane via Proline**
 - **This is the world’s largest plane**
 - **It landed in Mirabel on Sunday morning & had over 500k gowns**
 - Two additional GC chartered planes
 - 4m surgical masks, 1m+ pairs of gloves, 200k gowns
- **CanSino vaccines are still with customs in China**
 - **Embassy has a mtg tomorrow**
 - **Officials continue to store the vaccines in dry ice so that they keep**
 - **Assuming they get through customs tmrw, they can be put on a flight on the 27th**

PHAC:

- **Gov of China’s donation of 50k N95 masks tested & passed with 99.29% efficiency; will move to allocate**
- Warehouse received the following this weekend: 3.2m surgical masks, 1.7m face shields, 391k gowns, 5.6m nitrile gloves, 1.29m other gloves, 250k swabs
- **P/Ts are reluctant to accept certain kinds of N95s (reluctance is essentially towards everything that isn’t 3M, but discussions are ongoing)**

ISED:

- **Contract with fourth domestic supplier for 10k vents (Art McDonald design) signed over the weekend**
- CAE has submitted their HC package for approval meaning 2 / 4 domestic vent companies now have their materials in with HC
- Innovative solutions Canada was closing up a challenge on rapid test kits – they’ve narrowed applicants down to four firms who are going through final due diligence between w PHAC & NRC
 - Goal is for successful companies to be notified by the end of this week (May 29); could be up to four

Other:

- **GM contract for surgical masks will hopefully be signed & ready to be announced in the next 24 hours**
- **Officials said they would follow up w info on what regulatory action is being taken re: MDEL holders, such as Tango, who have provided masks that have consistently failed standards**
