Hello – spoke with Matt. We're good to add this one too if you'd like (and if it isn't too late, sry). A company in NB is able to supply enough reagent for the testing needs of all provinces on a weekly basis starting this week (and a bit extra, since max capacity is 371k test per week).

*PHAC is supporting COVID-19 testing across the country by supplying testing reagents to laboratories.*

*We have contracted with Luminultra in New Brunswick to keep provincial laboratories supplied with reagent so they can increase their testing capacity. This week, Luminultra will be providing enough reagent for 500,000 tests per week.*
