Hi Vanessa,

Following up with a few stats that may be worth including for tomorrow. FYI — N95s and gloves remain in high demand from provinces. The stats from the PHAC updates should be verified with Health, but we as we have received close to 100M pieces of PPE last month, I thought this may be of interest to highlight, particularly with the face shield domestic manufacturing piece.

Quantities inventoried by the NESS in September (August 31 PHAC update — October 1 PHAC update):

N95 masks: 16,639,400 (from international supply chains — mostly by GoC

chartered flights)

Face shields: 2,914.384 (100% received from domestic sources)

Test Swabs: 2,464,200 Pairs of gloves: 21,287,150 Gowns: 38,708,606

Surgical Masks: 12,425,250

Total: 94,438,990

Quantities distributed to provinces from the NESS in September (August 31

PHAC update — October 1 PHAC update):

Face shields: 7,407,665 Pairs of gloves: 21,321,900

Gowns: 189,962 N95 masks: 50,000

Surgical masks: 7,055,550

Testing swabs: 603,075

+ Made in Canada 3D printed swabs: Tronosjet Maintenance Inc. (located in Charlottetown) has become the second Canadian company to receive HC authorization for 3D printed made-in-Canada swabs. Discussions are underway with PHAC/PSPC to discuss procurement options (first company was Precision AMD out of Winnipeg)

Also, as mentioned, here is the section from Minister Anand's speech from Tuesday to illustrate the volume of PPE and medical supplies that the NESS now has:

"Through our procurements we now secured more than 2 billion items of PPE for Canadians. We will continue to receive steady ongoing delivery of all types of PPE in the coming months.

With this increase in numbers of PPE deliveries including approximately 40% of the total dollar value of contracts now going to domestic companies, our existing warehouses are stretched to capacity.

This is a sign of proactive PPE procurement but also why I am pleased to announce that, on behalf of the Public Health Agency of Canada, Public Services and Procurement has awarded a new contract to Metro Logistics Inc. of Montréal to assist in the warehousing and distribution of PPE to the provinces and territories.

As the delivery of orders continues, the Public Health Agency's increased capacity to store and distribute PPE is critical. In addition to PPE, logistics will be just as important when it comes to distributing vaccines."
