Hi there – numbers just in from PHAC:

- PHAC can confirm that 1.1M N95 products will be shipped to P/Ts this week from the fed gov.
- Approximately 820K N95 products were shipped to P/Ts last week.
- These N95 #s represent products procured by the GoC so we would not be taking credit for provincial orders here. ☺
- PHAC also received 8.39M gloves yesterday which will be shipped to P/Ts.

Based off the information above, some suggested changes / additions below.

Over the weekend, we received new shipments of essential personal protective equipment, including four planes of N95 masks (*one of which was for QC – which I see is in the French*).

As we speak, workers are unpacking and validating these supplies so that we can start shipping them to the provinces and territories as quickly as possible.

These new N95 masks are in addition to the more than 820,000 that went to the provinces last week. This week, we have 1.1M N95 masks ready to be shipped to P/Ts, with more on the way.

We have also received over 8.39 million pairs of gloves yesterday, and we'll be getting new protective gowns delivered from domestic suppliers starting next Monday.

[On testing, we are moving forward on a range of rapid testing kits, both from here in Canada and internationally. This includes Ottawa-based Spartan Bioscience, who will be supplying tens of thousands of kits over the next month, and potentially more as production increases.]
