We do not know what is in QC's order that was made independently of the GoC. Could be N95s but unclear – we're just giving them space on the plane because they were having delivery challenges.

Hi – just confirming the shipment from China to Canada contains 8 million surgical masks. Numbers will be verified upon the delivery's arrival – could be 7 million rather than 8 but we ordered 8.

We are also helping QC bring over their order that was made independently of us. Not sure anyone knows what precisely is in QC's order though.

The PM did mention the warehouse and I don't plan to get into more detail proactively. We have a previously PMO approved media response on the contract with Bolloré so would just provide that same info if pressed.
