Vexos received Health Canada authorization for their ventilator on September 21. We are working with the company and the Public Health Agency of Canada (PHAC) to finalize a delivery schedule.

CAE has filed an application with Health Canada and is working to obtain an authorization for their ventilator.

We continue to monitor demand from provinces and territories, preparing for any eventuality, as we have from the outset of the pandemic.

manufactured awaiting final approval; departments are working closely with them; Canada continues to prepare for any eventuality; we have several contracts with several ventilator suppliers & have started to receive deliveries of this product from them; we fully met the demand for vents to date; it's so great that companies are stepping up & delivering made-in-Canada things etc. One line from HC on the importance of a strong regulatory regime that ensures we're able to provide high quality products to Canadians in a timely manner could be helpful but I don't think it is mission critical. Thoughts?

The issue with that is we can't answer on the approval of the vents, will have to confirm that none have been received and will not be able to answer on the distribution, while as you have the regulator and PHAC under you, you can address the fact that ICUs are well equipped and that Canada has the vents it needs at this time, and has over the past number of months.

It may be helpful to have input from ISI on retooling and need for Canadian solutions, and we're happy to review the response.
