Thanks again for your reply! I hope to see some light at the end of the tunnel.

Hi Madison- nice to meet you.

I have not personally reach out to individual hospitals, was not sure if I was allow to do that without having any authorization from Health Canada.

Also, whom to contact at hospital level to assure mask will be distributed evenly?

I was afraid, If i had reached out myself, each hospital will want custom work, have too much input as to design, colour, fabrication....etc. That would take forever to customize for everyone.

Are you saying, each hospital purchases their own gowns and mask?

It's not all purchase by Health Canada than distributed to the hospitals? Pls advice.

A few of my friends, doctors and nurses are working on the frontline, they have reached out to me.

These are employees from four different local hospitals. I could not bare to just sit and not help them.

On Monday, I am starting production on my own out of good will.

Aiming to make 2000 masks. My plan is to donate 200 - 300 mask per hospital for now.

I couldn't find on the internet, how many staff are employed in each hospital?

If you have a source that I can obtain this info. Kindly share.

This way, I will have an indication of how many to send to each hospital.

Just yesterday, several of my own customers, local designers in high end clothing, are asking me to produce gowns and masks for them.

However, getting into custom work, it will slow down my production.

My goal is to get mask and gown out there as fast as possible. I have already secure fabrics and patterns all ready to go.

It would be more comforting and effective if I have the support from the government so that we can go full steam.

(I will not be able to fund all the materials, and labour costs myself for volume production)

However, I have enough resources, labour forces to make this all happen quickly.

We are located in Toronto in a 12,000 sq. ft facility. Would save so much time in shipping to all local hospitals. We are within 1/2 hour to downtown. I have many smaller factories in Scarborough, Mississauga, Vaughan, all local factories that does work for me.

Therefore, if you add up all my work force, will be well over 200 people. I have been in business for 26 years, it's a small industry.

You can easily call all suppliers and ask about TAMA DESIGNS. I know this business inside out.

I really didn't know whom to turn too, therefore reaching out to Tim, he was the 3rd person that called me from government dept. and the only one that replied back.

Madison, hoping you can help make a difference. Our frontline workers are all calling for help.

Thanks to both of you for hearing me out. I really appreciated.

BTW: If I am doing or saying anything against the law..... we never spoke!
