VOLUNTARY ISOLATION FACILITIES

- Throughout this pandemic, Canadians have changed their ways of life to keep each other safe.
- For many, that means creating new habits like washing their hands, social distancing, and staying home – staying away from people – when they are sick.
- We do this because self-isolation is one of the **most effective** ways to stop the spread of COVID-19
- But for some Canadians, self-isolating isn’t possible. They may not have enough room, or it might be too costly, making it unsafe – or impossible – to self-isolate.
- In September, we announced a pilot project with Toronto Public Health to create a **voluntary self-isolation centre** where people can **safely** and **voluntarily** stay if they are ill from COVID-19
- Because of the success of the Toronto pilot, we are now looking to **expand the program** so that other Canadians have access to these options when they are ill.
- These facilities are designed to help Canadians who are ill from COVID-19 **keep their loved ones safe**. The sites are to be managed **by local public health** and spots will be offered to eligible individuals
- People that choose to stay at this site are provided with **lodging, daily meals, health assessments, and other necessities**
- Canadians want to keep their loved ones safe. With these facilities, we provide them with **choices** so they can do just that.
