Hello Sean/Celine,

I am following up on my earlier email regarding N95 and surgical mask production, we have completed significant preliminary legwork regarding certification, securing supply and equipment and putting a plan of action in place.

We would require \$650,000.00 CAD to cover the cost of capital and commissioning labor to setup and operate a PPE N95 mask line and a surgical mask line.

Should a larger volume be required, it would be at a cost of \$260,000 CAD per additional piece of equipment.

We can have this line operational within 20-25 days.

Production rates are:

N95 masks: 30-40 pieces per minute per assembly line

Surgical Mask: 90-100 pieces per minute per assembly line

Additionally, RACER is a critical enabler of Canada's Key Industrial Capabilities (KICs) and we are willing and able to help! Thank you for your support.
