We are also receiving sea shipments and to date, have received 19 shipments totalling more than 3 million litres of hand sanitizer. This is in addition to the supplies delivered directly by suppliers, shipments coming in from suppliers in from the United States like 3M N95 masks, or the millions of testing swabs from Japan and South Korea for example, as well as the ongoing deliveries of made-in-Canada face shields, hand sanitizer and medical gowns among other domestically produced goods.
