Supply Council

- From the beginning we have been working with partners at all levels of government, and with industry, to secure life-saving medical supplies as part of a whole-of-government response to the COVID-19 outbreak.
- As part of our efforts, we have announced the COVID-19 Supply Council which will bring together a diverse group of leaders to provide advice on establishing further diversified and adaptable supply chains for key items so that we are prepared for any eventuality.
- This council builds on our collaborative approach to help us address current and future supply challenges, and ensure that Canadians have access to the supplies they need to stay safe and healthy
