Hi Chelsea,

We have further looked at the request below. Given that swabs and UTM for COIVD-19 testing are a class 2 medical device, the supplier needs to have a medical device licence authorized by HC through Interim order pathway.

We would recommend PSPC MinO to send letter to IC MinO with an explanation on "how to do business with the federal government" and next steps. However, if MinO already has the information that the company is already vetted and authorized through HC, the information should be sent to National Microbiology Laboratory (NML) as the tech authority. Could you please let me know if you have this information from the company to determine the best response?
