Hi there,

It looks like the PM will be providing an update tomorrow and so PMO is looking to include some stats and information on PPE and medical supplies received.

The numbers here are what I gathered from the PCO daily updates including the numbers inventoried by the NESS:

Quantities inventoried by the NESS in September (August 31 PHAC update – October 1 PHAC update):

N95 masks: 16,639,400 (from international supply chains – mostly by GoC chartered flights)

Face shields: 2,914,384 (100% received from domestic sources)

Test Swabs: 2,464,200

Pairs of gloves: 21,287,150

Gowns: 38,708,606

Surgical Masks: 12,425,250

Total: 94,438,990

I am wondering if PSPC may have somewhere handy (perhaps based on the webchart content that hasn't been posted) the numbers that we can account for.

Given I know that there have been discrepancies between what PSPC has estimated as received versus what PHAC has inventoried, we are looking for this info to pass on if possible.
