Dear Ms. Hajdu:

I hope all is well. I am a citizen of the Island of Montréal in the riding of Notre-Dame-de-Grâce. The elected MP, the Honourable Marc Garneau, asked me to contact you directly (see attached email).

We want to be part of the Government of Canada's efforts to replenish its personal protective equipment inventory to help fight COVID-19. Therefore, we propose manufacturing <u>protective gowns</u> and <u>surgical masks</u> made entirely according to the standards required by Quebec. Attached to this email is a description of the manufacturing standards required for each of the items (Appendices 1 and 2). Production capacity is measured per million of each product and factories are located in Vietnam. We have an excellent knowledge of the supply chains for importing clothing into Canada from Vietnam as we have been working in retail for 15 years. Deliveries are usually shipped in by boat and we are currently exploring the use of planes.

We would like to build a strong partnership to support the collective effort to take care of citizens while ensuring adequate equipment to protect health care workers. **If there are needs to be met, we would be happy to engage in discussions with you to provide our services and clarify quantities, timelines and prices.**
