I hope this email finds you well. I am currently working in China sourcing medical supplies for the Hong Kong government, the US government and various other clients in Central Asia. By luck would have it I just recently came across one of my contacts who have 6000 ventilators in stock ready to go. Coupled with the supplies of my other contacts I have around 7000 ventilators in stock. I have attached the prices and the model info in this email.

Given ventilators are in short demand right now I thought it would be best if I tried contacting you even on a Sunday. Prices are likely to go up as suppliers are scrambling to try and make a profit out of this. I also have multiple US states looking to buy this shipment, thus I hope you are an early riser!

I do also have multiple supply lines to masks. I can get 20 million capacity each day of surgical masks and half a million N95 masks per day. I am sourcing face shields, gloves, protective coveralls, test kits etc for other governments. I would love to work in a more direct capacity with your government. I have attached also proof that I work with the HK government.
