Creating a \$77.5 million Emergency Processing Fund to help food producers **manage new challenges:** adapt to health protocols, automate or modernize their facilities, processes, and operations, and respond to emerging pressures from COVID-19 adjust or modernize their facilities, processes, and operations, so they can better supply Canadians with food during this period.

Also, apparently, "skim milk powder" should also be removed, as its unclear if that's what it will go towards and it's a 'gger word for bad blood on CUSMA concessions.

ISED and PSPC were not aware this was happening until one hour ago. Preference is to hold this and save it for a broader PPE update — a lot of stuff needs to happen first from their end, but if its mission critical for tomorrow, they can endeavor to get that done.

Also, this is not right: "This will [...] **complement recent efforts to increase domestic production of PPE for Canadian industry, including food producers.**" We are not producing PPE for non-healthcare workers. Can we just say "This will [...] **complement our efforts to increase domestic production of PPE.**"? Is that ok?
