HC APPROVALS: May 19

MEDICAL DEVICES

As of **May 15**, Health Canada has authorized a **total of 171** medical devices under the *Interim order*.

- **19** test kits
- **152** non-diagnostic devices (non-IVDD devices):
 - **8** N95 masks
 - **39** surgical masks
 - **43** face shields
 - **6** ventilators
 - **10** gloves
 - **4** sterilizers
 - **42** Others (thermometers, airway management, beds, swabs, isolation kits, ventilator accessories, AI for diagnosis, test reagents, monitors, software, sterilizer solution, glucose monitoring, Spirometer, Bipap, CPAP helmets, infusion pumps and a thermal camera).
- Health Canada is **currently reviewing**:
 - **39** applications for **test kits**
 - **727** applications for **non-diagnostic devices**

HAND SANITIZERS & DISINFECTANTS

As of **May 15**, Health Canada has authorized:

- **80** disinfectants
- **2,200** new hand sanitizer products
- **1,528** new site licences for over-the-counter drugs and natural health products.
