Importance: High

Hello,

For your awareness that tomorrow PSPC is planning to post the attached chart of PPE related contract values (in consultation with PHAC). They will release the figures with two caveats:

- Given the global nature of the pandemic and the severe competition for goods, PSPC is protecting the names of suppliers for certain hard to procure commodities, namely n95 respirators, gloves and swabs.
- Total contract values are not being disclosed in situations where the government has previously disclosed quantities of units ordered in a given contract.

I am expecting to receive related Qs&As soon, but wanted to ensure you see what they are aiming to post tomorrow. The charts will then be refreshed weekly as part of PSPC's procurement updates on orders and deliveries.
