Hi – spoke with Andrew about this earlier today and it just came up on the call. Stryker is extremely keen to announce their sanitizing machines that we have ordered. Health professionals are concerned about this – it's a huge culture shift for folks. It also undermines our messaging about being able to get what we need, and PTS have indicated they would use these as a last resort only. **So, any announcement of this needs to be VERY carefully done and should be led by health as a broader approach in my opinion**.

IE – This is something that would blow up a few days for the government. It would be great to avoid just dropping the info casually in comms materials.
