I hate to split hairs but not all of the 100m masks & 40m gloves are on their way to P/Ts.

Some could be on the way, some could have already been received by P/Ts, some could be stored away in the stockpile with zero plans in the foreseeable future for them to be sent anywhere (a portion of these supplies automatically go into the stockpile & stay there unless there is an extremely urgent shortage somewhere), some could have failed testing & we haven't found a home for them yet etc.

Safer bet might be something like "we have received x masks, y gloves and continue to send all sorts of supplies to P/Ts". Defer to you on how to thread that needle aha.
