Hi again,

Health Canada has shared a few additional details following this authorization. I was advised that they don't usually update their media lines for every new authorization, however I thought this short brief would be useful.

- On October 6, Health Canada issued an authorization under the Interim Order for the Abbott Alinity m SARS-CoV-2 test.
- The Abbott Alinity m is a molecular PCR test for use in laboratory settings, using nasopharyngeal and oropharyngeal swabs collected by a healthcare provider. Clinical evidence from the manufacturer indicates 100% sensitivity and 96.5% specificity.
- The test is intended for use in patients who are suspected of COVID-19 infection.
- In the context of the pandemic, Health Canada has already issued authorizations under the Interim Order for the following tests:
 - o Abbott Realtime SARS-COV-2 PCR COVID test (March 25)
 - o Abbott Architect (May 14)
 - o Abbott Alinity (June 11)
 - Abbott ID Now (Sept 30)
 - o Abbott PanBio (October 5)
