We are just hearing from PSPC that tomorrow Minister Anand will announce that as of August 3, 2020, organizations can apply for PPE from the Essential Services Contingency Reserve. While organizations and businesses are responsible for procuring their own critical supplies, this reserve is being established as a temporary measure to provide a backstop when other sources of supply are unavailable.

PCO Comms, Policy, Legal and IGA will review concurrently, and I will keep you posted on any comments or concerns.
