Hi all,

We can update our PPE web chart tomorrow around noon – attached is a preview of latest version as well as last week's for comparison.

This is still awaiting DMO approval on our end (I'll let you know if it changes anything).

Highlights:

We've received almost 5-million litres of hand-sanitizer (went from 87k litres to 5.1-million litres)

Our order numbers are stable – no new cancelations (but no new adds either).

Face shields and gowns each up by about 1-million.

N95s are up by about 250k

As discussed, we weren't planning to put MAA up again this week for this but recommend next week.

We will flag this update to a few journalists who follow this closely - who will likely rejoice we aren't updating late on Friday...
