I can confirm our Department's interest on moving quickly with this issue and that our DM and MINO are aware and also agree on the need to proceed soon. The stakeholder pressure has been primarily coming via certain provinces (e.g., NL and NS) in calls with DPM Freeland and PCO senior officials and relates to concerns expressed by certain industry stakeholders (for example, in food processing sector). This issue was discussed with relevant parts of PCO (IGA, LSMP, ERDP) and they are all supportive of moving with this measure.

Hi Patrick,

I hope you are keeping well through this time. As you can imagine, we have been focused on urgent, time sensitive COVID-19 related files over the past few weeks. You would have seen the messages from the Secretary and me indicating that the bar is high for proposals going forward at the moment given the system's focus on those initiatives which are most critical to the COVID19 response. There is also an increased interest in stakeholder dynamics as you can imagine; we have seen that play out on some files recently.

Therefore, I am doing a signal check with you to confirm your department's interest in proceeding at this time and to also confirm, if that is the case, that there have been signal checks done with respect to potential stakeholder dynamics.

I understand that Finance Canada, in consultation with PCO, hope to have a GIC decision on this remission order as soon as possible. We would appreciate it if you could provide additional insight on any hard deadlines that may be in play and an estimated timeframe within which we could expect the signed submission.

It is expected that TBS senior management, our Minister's office, and TB Ministers will ask questions about the priority, timing, and potential implications within the current context as any file moves forward. We are receiving those types of questions even on high profile COVID-19 related files.

Your response to by noon on May 1st would be greatly appreciated in order to facilitate our planning.
