Chinese Consuls around the country are reaching out to Mayors and other elected leaders to say that they can send us medical equipment (masks, ventilators, tests, etc.) on an expedited basis (like on planes asap).

Would it be possible for you two to chat and get Minister Champagne to call the Chinese Ambassador today to see what the possible is.

I think if the Ambassador is open to helping, we can then connect Chinese officials here with senior procurement folks to get exactly what we need.
