We are recommending we abandon this request. Here are a number of factors to consider:

- The article was published four days ago and can be considered old news
- The article is factual
- The article doesn't say that PSPC did not respond to a request for information
- While there are a number of comments about the article, this "news" hasn't been picked up by any other major news outlets (nor have we received questions from other reporters)
- The intern journalist who wrote the article finished his internship and left the National Post last Friday and no other journalist or editor have followed up on his request (the reporter never copied anyone else from the National Post on his emails)
- The numbers in the article are accurate (from Open Government)
- If we were to make a valuable contribution, it would be to explain why SNC is still receiving contracts but the article already touches on that, and by now, this would be best in a letter-to-the-editor, but even after four days, it is a bit late
- If we were to make a valuable contribution, it should not be numbers; that would just be confusing and warrant further follow-ups from the newspaper as the numbers in the article are factual already

Considering these factors, let us know if you agree with Media relations closing this request.
