Good news: we are re-inventing the chart this week as discussed.  
Bad news: won't be ready until the afternoon at the earliest.

The issue, it seems, is that acquisition wasn't really keeping a running tally of deliveries – so they have had to go back through the daily reports and manually count. Also, goods coming in on our chartered flights is being tracked separately from deliveries made by domestic suppliers – so they need to marry those two numbers. All that to say: they need a little more time to make sure they counted right.

Other good news: Dept feels that if they get this first chart right, they will have a solid base-line and system in place to make future updates much easier.

However, this doesn't change the fact we aren't going to have reliable numbers in time for the critics call.

Can it be postponed with an explanation that we are changing reporting methods and want to ensure the new numbers are accurate?

Or do we want to try and talk around it again in the hopes that, it being the last sitting day, they don't actually care that much....?
